Minutes of Meeting of Highways, Rights of Way and Parking (H.R.P) Committee Held on Monday 10th June 2024 at 7pm in the Town Council Offices

- 1 Present: Cllrs P Wraight, Dean, Eastwood and Bennett and one member of the public
- 2 Apologies: Cllr Moffatt (other commitment), Mark Benbow (other commitment), L Kindred (bereavement). With the absence of a clerk, Cllr. Eastwood volunteered to take the minutes.
- 3 Appoint a new committee Chair: There being no-one present prepared to take over the Chair, Cllr Eastwood agreed to chair the meeting
- 4 Minutes of the 8th April 2024 meeting were approved as a true record.
Proposed Cllr Eastwood, seconded Cllr Bennett, unanimous

Public comment:

A resident complained about the lack of progress in clearing the drains on Station Road. Agreed to ask the DTC to chase Highways again and to express our frustration about the length of time taken to clear up the problem. **ACTION**

 - 6.2 Consider lighting at the Fairfield Road end of The Fens footpath. Proposed to accept the quotation from Pearce and Kemp, to be paid for from the money already set aside from CIL. Proposed Cllr Eastwood, seconded Cllr Bennett, unanimous **ACTION**

Email from SCC regarding unlicensed bunting. This has been passed to the retailer who erected the bunting and our County Councillor made aware of the demand. DTC asked to enquire of SCC details of the licencing process, including insurance. **ACTION**

Request for mobile campervan to park in town centre for a day. The Committee is happy with this but agreement will be required from ESC to suspend parking restrictions depending on the place chosen.
