Applications will be considered at the next available meeting of the Lands and Markets Committee.

Once approved you will be notified in writing and will receive a copy of the current Framlingham Market Regulations, Saturday Market Traders Parking explanatory letter & map, GDPR Privacy Notice & Contact Consent Form.

After notification, to progress your application further you are required to pay a £10 admin **fee (please notify the town Clerk with date payment made)** and to have provided all the required documentation/information, as stated above, before an Annual Licence to trade on the market can be issued and your Parking Permit if applicable.

To complete the process a signed copy of your Licence and Contact Consent Form will need to be received at the Town Council Office within the required period and before you trade on Framlingham Market.

**Regulars pay £1.10 per foot April - September and £0.90 per foot October – March.
Payment to be made quarterly in advance on receipt of invoice.**

**Casuals pay £1.60 per foot April –September and £1.40 per foot October – March.
Payment to be made on a weekly basis to the Market Supervisor-Darren Smith – (Fish Stall)**

Electricity is available at a cost of £3.50 per day

(Once established traders can pay in advance per quarter and benefit from a reduction of 10% off the pitch fee for prompt payment).

The Market rents and regulations are reviewed annually and a copy of the market regulations is available on request or can be downloaded from www.framlingham.com.
